Regular Agenda Items

Treasurer's Report. The BoD approved the Treasurer's monthly report.

March total income was \$695.80: \$265.21 Kroger, \$330.00 Venmo, \$100.59 Paypal.

Expenses of \$1348.66 include \$2 in bank charges, \$97.45 in business expenses, \$95.00 for plaque for past board member, \$9.00 in ongoing camera expenses, \$15.70 for toilet paper, and \$983.79 for NRA Counselor training hotel (Tom).

Totals show a net loss of \$652.86 for the month of March and a YTD net loss of \$3010.72.

Total current assets are \$9404.06.

Range Master's Report. The BoD approved the Range Master's monthly report.

Documented visitors totaled 161 in February - 37 on the weekends and 124 on weekdays.

RSOs volunteered a total of 40.5 hours of RSO shifts this month comprised of 11.5 hours on weekends and 29 hours on weekdays.

There is a significant amount of brass to be recycled.

Cameras are working but brass is still being stolen. Two additional cameras will be purchased to capture faces and license plates. There was a discussion of placing cameras in the shooting bays. BoD decided to not post camera in use signs.
