Meeting Convened

Regular Agenda Items

Treasurer's Report. The BoD approved the Treasurer's monthly report.

May total income was \$436.85: \$44.57 Paypal, \$177.00 Venmo, and \$221.57 from Kroger.

Expenses of \$1149.47 include \$100.66 in business expenses (bank, PayPal, ink, software), \$57.80 for Board meeting food, \$648.95 for range expenses (cameras, clays, earplugs), \$83.24 for RSO expenses (training and vests), and \$275.82 for WOT materials.

Totals show a net loss of \$712.62 for the month of May and a YTD net loss of \$6923.00.

Total current assets are \$5763.81.

Range Master's Report. The BoD approved the Range Master's monthly report.

Documented visitors totaled 261 in May - 148 on the weekends and 113 on weekdays.

RSOs volunteered a total of 38.5 hours of RSO shifts this month comprised of 23.5 hours on weekends and 15 hours on weekdays.

Purchased 4 boxes of clays, 4 boxes of earplugs, and 24 rolls of duct tape.

Work day on 5/31 (58 non-RSO hours and 10 volunteers). There were 50 backers cut, trash was picked up, 25/50 yd rifle stands replaced, and four 100 yd target frames were replaced. 1100 lbs of brass was sorted and loaded.

Secretary's Report. The BoD approved the April 2025 minutes.

Previous items:

100 yd rifle stands were delivered and all work completed.

More bucket stickers were ordered, received, and are at the range.

No trespassing sign was finalized and approved. It will be submitted to the county for printing. Purpose is to allow county to prosecute.

SRA classes - WOT scheduled for 7 Jun; BP scheduled for 28 Jun; and CHP scheduled for 26 Jul.

Target frames were ordered.

Grant paperwork is in progress.

Range protocol signs are ready to be mounted.

Shotgun range grading is complete.

New Business:

Basic Pistol classes will be held at Elk Lodge. Classroom instructors are set but more range instructors are needed.

Range supplies need to be purchased (17 HMR, 9mm, and targets).

Discussed changing rules for brass collection to preclude people from picking up brass that doesn't belong to them.
