Meeting Convened

Regular Agenda Items

Treasurer's Report. The BoD approved the Treasurer's monthly report.

March total income was \$65.00: \$25.00 Paypal and \$40.00 Venmo.

Expenses of \$2972.63 include \$392.97 farewell expenses (outgoing secretary), \$259.54 in business expenses (software, bank charges), \$63.13 for Board meeting food, \$433.20 for counselor training (Tom L, hotel, baggage fees etc.), \$1239.70 for liability insurance, and \$584.09 for additional cameras.

Totals show a net loss of \$2907.63 for the month of March and a YTD net loss of \$6089.79

Total current assets are \$6496.43

Range Master's Report. The BoD approved the Range Master's monthly report.

Documented visitors totaled 140 in April - 77 on the weekends and 63 on weekdays.

RSOs volunteered a total of 29 hours of RSO shifts this month comprised of 11 hours on weekends and 18 hours on weekdays.

There is a significant amount of brass to be recycled.

Cameras are working but brass is still being stolen. Two additional cameras were purchased and installed.

Brass no theft stickers were installed on brass buckets.

Secretary's Report. The BoD approved the April 2025 minutes.

Previous items:

Dan has a meeting with the benefactor helping with the long range stands on the rifle range.

BoD decided to not pursue grand opening pictures.

Installed cameras are useful but brass is still being stolen. There was a discussion on changing our brass signs to SRA owns all brass at the range.

An adjustment to the no trespassing sign wording was discussed.

Shotgun range work should be completed shortly.

New Items:

Range hours are still incorrect on various pages of the website. Outdated brochure was removed.

Work day date scheduled for 31 May 2025. Goals are to sort brass, hang protocol signs, pick up trash, cut backers, and do preliminary work for grant work.

Frames need to be ordered and paid for \$33 each x 50. Earplugs and duct tape are getting low.

SRA WOT class request for instructors - 7 volunteers - 10 students registered so far.

SRA Basic pistol is the next SRA class scheduled for 28 Jun 2025.

SRA Concealed Carry class scheduled for 26 Jul 2025.

Metal work for rifle range (grant) will be completed this month.

Discussed installing cameras on firing line - paused at this time.
